Procedure

Registration

The client submits their identity details (Identity document / Passport / Driver's License) to the vendor.

The vendor captures the details and submits the information to BioIdentity over the internet or direct connection.

BioIdentity checks for non-duplication and then registers the client along with their details.

Verification

The client initiates a new transaction when purchasing something or when his identity has to be confirmed. He does this by placing his finger on a fingerprint scanner. BioIdentity then returns a positive, negative or unknown result.

If the result of the verification process is positive, the vendor can then proceed with the transaction knowing that the true identity of the client has been established.

Secure Transaction (optional)

This system can be integrated into any transactional system to enable the secure processing of any type of financial transaction that is identity bound. This eliminates all hacking attempts as well as ensures security for the client, the merchant as well as the financial institution.
